

**American Legion Auxiliary, Department of Wisconsin  
2016 Daily Sweepstakes**

**OFFICIAL RULES**

1. **ELIGIBILITY: NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE.** Making a donation to American Legion Auxiliary, Department of Wisconsin ("Sponsor") will not improve your chances of winning. Sweepstakes is void in New York and Florida or where otherwise restricted or prohibited by law. To enter the American Legion Auxiliary, Department of Wisconsin Sweepstakes (the "Sweepstakes"), you must be: (i) a current or former member of the American Legion Auxiliary, Department of Wisconsin or a friend or family member of a current or former member; (ii) a citizen of the United States or a lawful permanent resident of the United States; (iii) 18 years of age or older at the time of entering the Sweepstakes; and (iv) not be considered a minor in your state of residence. Employees of American Legion Auxiliary, Department of Wisconsin (the "Sponsor"), its respective parent, subsidiaries, licensees, agencies and affiliates ("Sweepstakes Entities") and members of the immediate families (spouses and parents, siblings, children and their spouses and in-laws) and persons living in the same household (whether related or not) of such individuals are not eligible.
2. **TO ENTER SWEEPSTAKES:** Sponsor will print a total of 50,000 entry forms and mail two entry forms to each member or former member appearing in Sponsor's mailing database. Approximately 44,000 entry forms will be mailed to current and former members. Additional entry forms are available on request, while supplies last. Multiple entries by the same individual are allowed.

The Sweepstakes entry period begins on August 15, 2015 and ends December 31, 2015 (the "Entry Period"). To enter, complete the official Sweepstakes entry form included with the letter you received from the Sponsor and mail, no later than December 31, 2015, the completed entry form to American Legion Auxiliary, Department of Wisconsin, PO Box 140, Portage, WI 53901-0140.

All entries must be post-marked on or before December 31, 2015. Sponsor is not responsible for late, lost, damaged, illegible or misdirected entry forms, or incorrect or out-of-date mailing addresses.

3. **PRIZES:**

A total of 366 cash prizes totaling Eleven Thousand Eight Hundred Thirty dollars (\$11,830.00) will be awarded to entries received during the Entry Period according to the "2016 Prize Calendar" included with the entry form and located at [www.amlegionauxwi.org](http://www.amlegionauxwi.org).

Each valid entry is eligible to win each drawing held during the Sweepstakes.

Three hundred and two (302) fifteen dollar (\$15) prizes will be awarded in three hundred and two (302) separate daily drawings during the Sweepstakes.

Fifty-two (52) twenty-five dollar (\$25) prizes will be awarded in fifty-two (52) separate drawings during the Sweepstakes.

Twelve (12) five hundred dollar (\$500) prizes will be awarded in twelve (12) separate drawings held during the Sweepstakes.

4. **DRAWINGS:** All prizes are non-transferable and subject to Federal Income Tax withholding requirements. Each winner will be selected from all eligible entry forms received and/or credited in a daily random drawing held each day during the Sweepstakes Period. Each selected winner will be notified by Sponsor via telephone, mail or the email address supplied during entry at Sponsor's sole discretion. The odds of winning each day depend on the total number of eligible entries received. The Sponsor's decisions are based on its sole discretion and interpretation of these official rules, and are final and binding in all respects.

5. **GENERAL:** By participating, entrants agree to be bound by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects and in all matters relating to this promotion. By participating, entrants and winners grant to Sponsor, and Sponsor's advertising and promotion agencies, the right to use entrant's and winner's name, photograph, likeness, statement, image and/or recorded audio and video footage, for trade, advertising, publicity and promotional purposes in perpetuity without compensation (unless prohibited by law) by Sponsor and those acting pursuant to Sponsor's direction, in all media now known or hereafter discovered, worldwide, including but not limited to the World Wide Web, without notice, review or approval and agree to execute specific consent to such use if asked to do so. Individuals winning more than \$600 will be required to complete an IRS Form W9, which must be returned within the time specified by Sponsor. If documents are not returned in a timely manner, are returned as non-deliverable, or if winner is found to be ineligible or not in compliance with these Official Rules, winner will be disqualified. All taxes on prizes and expenses relating to acceptance and use of prizes and not specified are the sole responsibility of winners. Sponsor may prohibit an entrant from participating in the Sweepstakes or winning a prize if, in its sole discretion, it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, deception, or other unfair practices or intending to annoy, abuse, threaten or harass any other entrants, Sponsor, or Sweepstakes Entities. Sponsor, its advertising and promotion agencies and all of their respective parents, affiliates, subsidiaries, agencies, agents and representatives and their respective employees, officers and directors are not responsible and shall not be liable for: (a) any human error which may occur in the processing of entries; (b) lost, late, damaged, illegible or misdirected entries or incorrect or out-of-date mailing addresses; or (c) any condition caused by events that may cause the promotion to be disrupted or corrupted.
7. **CHOICE OF LAW AND VENUE:** Except where prohibited, entrants agree that: (a) any and all disputes, claims, and causes of action arising out of or connected with this promotion, or any prize awarded, or the determination of the winner, shall be resolved individually, without resorting to any form of class action; (b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this promotion but in no event attorneys' fees; and (c) under no circumstances will entrant be permitted to obtain awards for and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
