They are currently asking members to contact your senators to support Senator Elizabeth Dole 21<sup>st</sup> Century Veterans Healthcare and Benefits Improvement Act. This Act has passed in the House and is now in the Senate for consideration. The Dole Act is a comprehensive veteran’s package. That includes several important provisions, including support for home and community Based services, authority to award grants for mental health support to family caregivers, and Veteran directed care. The American Legion supports this legislation. Why did I join the service? Love of country, family tradition and adventure. I am retired but I still go out and do exercises as a nasty contractor.

I started my career in Fort Sill, Oklahoma for artillery training. Then to Germany, and the night I had staff duty, is when the Berlin Wall came down. Went back to Fort Sill and went into the Reserves and basically did operations for logistics experience. Went back on active duty and was sent to Fort McCoy to help Units deploy. Was then reassigned to Headquarters US Army Europe. Was assigned to Fort Worth as chief of operations. Was in Fort Riley for RTC training. Deployed to Iran and helped to develop a sharepoint for a lot of different tactical products for the division. ## 10<sup>th</sup> DISTRICT UNIT DUES

**Article III Sec. 1 of the 10<sup>th</sup> District ByLaws states:**

## INDEPENDENCE AUXILIARY UNIT 186 CELEBRATING 100 YEARS

One hundred years ago in 1924 The Independence Wisconsin American Legion Auxiliary Unit 186 became a charter member. The first officers were. President Ava (Frank) Tubbs, Vice President Agetha (Albert) Marsolek, Secretary Irene (Sydney) Briggs and Treasure Monica (L.F.) Tubbs. Going through old member roster's, minutes from meetings, and notes on just about everything we were able to find 380 former members. 179 are buried at SS Peter and Paul cemetery, 19 are buried at Bethel cemetery, 23 are buried at Greenwood cemetery and the remainder members who have passed are buried throughout the United States.

As a giving organization we've decided it's time to recognize these great ladies with a bronze grave marker similar to those placed on our veteran graves. Placement of markers, in our local cemetery's, will start with the most current then systematically go back to all those who have been identified as members. Why you wonder recognize these women? One answer ... unselfish generosity. During the hard years of the depression, they contributed to the school milk program for children in need along with food baskets and clothing drives for needed families.

The war years brought purchasing War Bonds to support our troops. Donations of supplies for the brave souls in the Veterans hospitals at Wood, King, Madison, Tomah, and our local hospital in Whitehall WI. They have supported: The State Rehabilitation Fund, Child Welfare Fund, Easter Seals, The Red Cross, Gifts for Yanks Blood Drive, The Salvation Army and the U.S.O.

As The American Legion Auxiliary *this is what we do* and in 2024 100 years after our mentors started this organization, we continue to support the Badger Girl State, the Veterans Poppy Drive, our community, our schools, our veterans, area nursing homes and the needs of others along with supporting the State Veterans Home in Chippewa Falls. With the grave markers costing more than \$50.00 each we have indeed taken on an ambitious project. But with a plan and positivity all our goals have become attainable. Thanks to all the kindness and support of our Auxiliary families and our community our grave marker placement has now begun.

On September 4th prior to the regular monthly meeting Auxiliary members placed 20 Auxiliary markers on grave sites at SS Peter & Paul and Greenwood cemeteries. Our current President Debra Kampa placed the first marker on the grave of Agatha Benigna Marsolek (Mrs. D.A.), our organization's first Vice President. At the present time we have reached 50% funding of are goal of 222 markers.
