As we close in on the start of Unit reporting season, we get a year-end review of all the volunteer hours and contributions to Serving our Veterans, Military and each other from the depths of our Hearts. But don't let the end of the reporting year stop you from moving forward in the next year and continue the wonderful commitment to God and Country!

The 2024-25 National Security program has focused on 600 plus Wisconsin National Guards and Reservists deployed to the middle east and the southern border communities. Units have sent packages, coupons, mail call and provided family support during this time. Wisconsin Guards and Reservists are still deployed and will likely continue to be on the move with the flurry of unrest across the globe. Full-time active-duty military and their families are experiencing multiple deployments, relocations that translate to new schools and new friends for our military children.

Units are gearing up for April 15<sup>th</sup> Purple Up! Day, as April is the month of the military child. Please don't hesitate to contact me and click on the Wisconsin National Security Program page if your unit is looking to participate in Purple Up! and need more information.

In addition to the month of the Military Child, April brings recognition days such as Gold Star Spouses Day on April 5<sup>th</sup>; National Former POW/MIA Day on April 9<sup>th</sup>; and Air Force & Army Reserves Birthdays. Celebrating or recognizing these service men and women on their day brings us all closer together.

May is the month of the Military Caregiver and National Military Appreciation. May is filled with opportunities to serve, recognize and appreciate our military communities. # Visibility, Involvement, and Engagement

Whether it's fundraising, program support, or membership, building stronger connections within the community is critical to our continued success, and perhaps our very survival as a local veteran service and support organization. Strong relationships are built largely on three primary aspects of public relations efforts: visibility, involvement, and engagement.

- 1. **Visibility: Be Seen and Heard.** *Participate in Local Events*: Attend public meetings and other community activities. Wear the Auxiliary brand. Being present where people gather is an excellent way to increase your visibility. *Leverage Social Media*: Share posts about local events, volunteer opportunities, or interesting stories of your members. *Collaborate with Local Organizations:* Partner with schools, non-profits, and civic groups on projects and events. Make us more visible and approachable.
- 2. Involvement: Take an Active Role. Volunteer. Consider tutoring, cleaning up projects, or food drives volunteering helps us make a direct impact while meeting like-minded individuals. Use social media and word of mouth to communicate how your members volunteer throughout the community. Join Clubs or Committees: Our members who participate in other groups or clubs make great advocates for presenting and explaining our ALA purposes and programs. Support Local Businesses: Know and support local shops and restaurants show support for the neighborhood. If you do not have your own facility for events, partner with local businesses that can provide a proper venue.
- 3. Engagement: Build Meaningful Connections. Listen and Communicate: Strong engagement starts with understanding others. Ask local leaders (business, government, school) for advice on how to better serve the community. Invite them to your events, learn their stories while sharing our mission and our values. Advocate for Causes: Being an advocate for our own programs, community improvement efforts, or improving local education, builds trust and lasting relationships. Be a Solid Community Partner: Be ready to assist and support community and school groups. Let them see how much we care about where we live and the people who live there.

Building community trust requires consistent actions on our part. Start with small steps—attend one event, meet one community leader, volunteer for one project. Over time, your visibility, involvement, and engagement will grow, building strong community support and a positive reputation.

# OFFICIAL CALL TO THE 2025 ALA DEPARTMENT CONVENTION

## **Department Convention**

The 2025 American Legion Auxiliary Department Convention will be called into session at the Hyatt Regency/KI Center, 333 Main Street, Green Bay, WI 54301 at 9:30 a.m. on Friday, July 18, 2025.

## **Purpose**

The purpose of the department convention is to elect officers for the 2025-2026 administrative year; elect delegates and alternates to the national convention; amend the department's governing documents as needed; receive reports of the department officers and chairmen; recognize outstanding unit achievements; and transact business as may be brought before the convention body.

# Representation

Representation in the department convention shall be by unit per the department constitution. Units with less than ten paid members or whose district dues have not been paid shall have no representation. Delegates to department convention shall be unit members duly elected for that purpose.

Prior to department convention each unit will receive information showing the total number of paid members as of June 18, 2025 and advising them of the number of delegates and alternates the unit is allowed. It is the responsibility of each delegate and alternate to attend convention sessions so the district has a full delegation at all times. An alternate shall have all privileges of the delegate when the delegate is not present.

Delegates-at-large include all Department Officers, National Executive Committeeperson (NEC), Alternate NEC, Past Department Presidents, and current District Presidents\*, who shall each be entitled to one vote at the department convention. Delegates-at-large shall be listed separately and not included among the unit's total allowable delegate/alternate count. Units must return a list of their delegates-at-large and approved delegates/alternates to department headquarters for voting certification.

\* Incoming Presidents of Districts 2, 4, 6, 8, 10, and 12 are not delegates-at-large for this convention. They assume their positions after installation of officers at convention and serve from 2025-2027.

All attendees to Department Convention must pay a registration fee to The American Legion, pick up their name badges and voting credentials by 8:00 am on Saturday, July 19<sup>th</sup>, and be seated within their District for voting at 9:00 am. Business will resume as soon as voting is completed.

### **General Information**

**Deceased Members:** Names of deceased members that are sent to Department Headquarters by April 25, 2025 on a Member Data Form will appear in the Joint Memorial Service Program.

**Fundraiser**: Fundraising Chairman Laura Calteux will be conducting a raffle to raise funds for President Becky's special project, the national Auxiliary Emergency Fund. She invites units, districts and members to donate a raffle basket enclosed in cellophane with a list of the contents. ### **DELEGATES TO CONVENTION**

# **Constitution, Article VII: Department Convention**

- **Section 1.** The Legislative body of the American Legion Auxiliary shall be the Department Convention to be held annually for the purpose of electing officers, receiving reports, and transacting such other business as shall properly come before it.
- **Section 2.** The annual Convention shall be composed of delegates and alternates from each Unit. Each Unit shall be entitled to two delegates and two alternates for the Unit itself, and an additional delegate and alternate for each fifty members or major fraction thereof which it shall have in excess of fifty members, whose District dues have been paid, and whose State and National dues have been received by the Department Executive Secretary-Treasurer at least thirty days prior to the date of the Convention. No Unit shall be entitled to be represented unless it has at least ten members whose District, Department and National dues for the current year have been paid.
- **Section 3.** Delegates shall cast their own votes; the votes to be collected (in case of ballot), counted and announced without reference to district, as set forth in the latest edition of ROBERTS RULES OF ORDER NEWLY REVISED.
  - 1. An alternate shall have all privileges of the delegate when delegate is not present.
  - 2. A quorum shall exist at a Department Convention when there are present seven or more districts, wholly or partially represented.
  - 3. All Past Department Presidents shall be made delegates-at-large to the annual convention and entitled to vote.
  - 4. The Executive Secretary-Treasurer, Parliamentarian, Sergeant-at-Arms and Assistant Sergeant-at-Arms shall be delegates-at-large to the Department Convention and entitled to vote.
  - 5. Members of the Department Executive Board, as defined by the Constitution, Article V, Section 2, shall be seated as delegates-at-large with vote in the Convention.
  - 6. The Convention Credentials Committee shall be the final judge of qualification of delegates.
  - 7. Proxies shall not be permitted.

# Standing Rules: Department and National Conventions, Executive Board Meetings and National Meetings

- 13. The delegates and alternates to department convention shall be chosen by a plurality vote of the members of the unit who are present at a meeting called for that purpose. If at any time of the department convention, a duly elected delegate and alternate shall be unable to attend, the Unit President shall have the power to appoint a substitute delegate and alternate.
- 14. A list of the elected delegates and alternates from each unit must be filed with the Department Executive Secretary-Treasurer at least fourteen days before the opening of the department convention except in case of appointment by Unit President as provided in Section 13, and of Units organized within fourteen days preceding the convention. Otherwise no representation shall be allowed.

# **NOMINATIONS OF DEPARTMENT & NATIONAL OFFICERS**

Friday, July 18, 2025

**Department Bylaws, Article I, Section 1:** The following officers shall be elected annually at the Department Convention by a majority of the ballots cast. When there is but one candidate for an office, the nominee can be elected by voice vote or acclamation: Department President and Senior Vice President.

The following officers shall be elected annually at the Department Convention by plurality vote of the ballots cast. When there is but one candidate, the nominee can be elected by voice vote or acclamation: First Vice President, Second Vice President, Historian and Chaplain.

**Department Standing Rules, Elections and Campaigns, #2:** In line with The American Legion Counsel General's opinion, any member may run for any office as a right of membership. While each experience as an officer or chairman helps to prepare the member for higher office, members have the right to pursue any office that is personally fulfilling without obligation to seek other offices.

# NOMINATIONS FOR NATIONAL CONVENTION ALTERNATES

Due to Department Headquarters by June 1, 2025

**National Constitution, Article VI, Section 2:** Representation in the National Convention shall be by Departments. Each Department shall be entitled to delegates based upon the number of members whose dues are paid up-to-date as provided in the Standing Rules.

**National Standing Rules, Section II, Subsection 2**: Each Department shall be entitled to seven (7) delegates; and one (1) additional delegate for each one thousand two hundred (1,200) members or major fraction thereof, whose current dues have been received by the National Treasurer thirty (30) days prior to the meeting of said National Convention, and to one (1) alternate for each delegate. The delegates and alternates shall be selected not less than two (2) weeks before the National Convention at Department Conventions or in any manner specified by any Department Constitution.

Department Bylaws, Article III, Section 1, Subsections 5-6: Each of the twelve districts may nominate alternates to the national convention at the district level. The nominee selection process shall be determined at the discretion of the district, possibly at their spring or fall conferences, or by executive action. Names of nominees shall be sent to department headquarters as soon as selected and no later than June 1<sup>st</sup>. There shall be no nominations from the floor and election of alternates shall be held at a designated time during department convention and named in order of plurality count. No alternates elected at department convention shall be named to fill vacant positions until all delegates have been selected according to the [priorities stated in subsections 1-4].

- Nomination forms for Alternates to National Convention were sent to all District Presidents and must be returned no later than June 1, 2025.
- Elections will be held on Saturday, July 19, 2025 at 9:00 a.m. in the convention hall.

# **VOTING PROCEDURE**

- 1) Convention delegate registration will close at 8:00 am on Saturday, July 19, 2025.
- 2) Delegates and delegates-at-large will be verified by the Convention Credentials Committee. The Convention Credentials Committee shall be the final judge of qualification of a delegate.
- 3) Voting packets will be prepared for each district containing ballots equal to the total number of delegates and delegates-at-large registered and certified by 8:00 am on July 19, 2025.
- 4) An alternate shall have all privileges of the delegate when the delegate is not present. Alternates will be seated in a designated section for the convenience of a District President to locate and expedite a replacement delegate. Alternates may only replace delegates from within their own unit.
- 5) Voting will be at 9:00 am on Saturday, July 19, 2025 in the convention hall. Promptly at 9:00 am, the American Legion Auxiliary's convention hall entrance doors will be closed, with no one being allowed to enter or exit until the voting process is completed. Only delegates and delegates-at-large shall be seated in their respective district's delegation during voting.
- 6) Districts will be called in numerical order to pick up their voting packet from the Election Judges.
- 7) Districts will commence the voting process after all packets have been distributed. Delegates must present their signed voting credentials to receive a ballot.
- 8) Immediately after voting has been declared ended, the Credentials Chairman, election judges and the tellers appointed by the Department President will move to a designated counting room to tabulate votes and convention business will resume.
- 9) The Judge of Elections will take results, compare numbers with the Credentials Chairman, and provide a written report to the Executive Secretary-Treasurer.
- 10) The Credentials Committee Chairman will give an oral report of total number of delegates, alternates and delegates-at-large by district that had registered to vote as of 8:00 am on July 19, 2025.
- 11) The Judge of Elections will give an oral report of the numerical results of the election and give the written report to the Department President.
- 12) The Department President will declare the winners of the election during the convention session on Saturday.

# PROPOSED RULES & ORDER OF BUSINESS

- 1) All cell phones will be turned off while the convention is in session.
- 2) Convention sessions shall be start promptly at the stated times.
- 3) A quorum shall exist when there are present seven or more districts, wholly or partially represented. All delegates must be seated within their districts.
- 4) Attendees may leave the convention hall only at the end of a speaker's report. Upon returning, attendees will remain at the back of the convention hall until the current speaker has ended.
- 5) District Pages shall be responsible for distributing all convention materials to the District's delegates.
- 6) Guests shall be honored at the convention by applause only.
- 7) Before the election, time shall be granted in the regular order of business to nominate candidates for Department and National Offices.
- 8) Nominations will not be called by roll call of each district. The nominators and the candidates will be called to the stage as a group. Districts with announced candidates for office will be called in numerical order. Other nominations will be asked for from the floor. There shall be no seconds to nominations.

- 10) Immediately following the nomination, each nominee shall be presented from the stage and granted one (1) minute to respond.
- 11) There shall be no nomination speeches for delegates to the National Convention.
- 12) When giving reports, chairmen shall address the presiding officer as "Madam President" and reports will be accepted by general consent of the convention delegates. If there is an objection, a vote will be taken.
- 13) All resolutions shall be referred to the proper committee for study and recommendation and shall be reported back to the convention for adoption or rejection. The resolutions committee shall present all resolutions.
- 14) Delegates desiring recognition shall go to the nearest microphone, address the presiding officer as "Madam President," and upon receiving recognition from the presiding officer, state their name, unit number and district number. A speaker shall be permitted to speak no more than twice on any one question but cannot speak again so long as any member who has not spoken on that question desires the floor. Debate on any question shall be limited to two minutes for each delegate.



# Honoring PDP Joan Chwala (2011-2012)

Past Department President Joan Chwala will be the honored guest at the 2025 Department Convention at the KI Convention Center in Green Bay, Wisconsin. Joan is a 44-year PUFL member of Unit 326 in Boyd, Chippewa County, District 10. She served as Department President from 2011-2012.

Joan's eligibility for membership is through the service of her father, Robert N. Morris, an Army medic who served in the Pacific Theater during WWII, of her husband, Earl T. Chwala, who also served in the Army during Vietnam, and her brother, Lorum "Lem" Morris also an Army veteran of the Vietnam Era.

Joan was an educator for 35 years, teaching children in grades K-8 in the Gilman School District. Following her retirement, she focused her energies on serving our veterans and their families through her volunteer activities. ALA Badger Girls State was blessed to have her serve as a county counselor for nine years and as the leader of the Americanism and Community Service interest groups. She shared her leadership skills by serving on various department and national ALA committees and in chairmanships. Joan was awarded the prestigious Toomey Award for her department history in 2008. While serving as department membership chairman in 2006-2007, she brought her "three ringed circus" to multiple membership round-ups around the state to encourage renewals and recruitment.



Joan's theme "Libraries of Love' stemmed from her love of reading and desire to ensure that veterans across the state would have access to reading materials that enriched their lives. The gifts she presented on behalf of the Department to each of the veteran's care facilities were quality reading materials including both books and periodicals. Continuing her dedication to veterans, Joan served as a hospital

deputy at the Chippewa Falls Veterans home for 7 years. The veterans living there recalled fondly their shopping trips with her.

Joan will be honored during the convention session on Friday, July 18<sup>th</sup>. Please plan to join in celebrating her years of service and share your memories of her year as Department President.
